POLICE REPORT:

Cpl. Carrado was on hand to discuss calls for service in the NAC 3 area and to address residents' concerns. The breakdown of calls for service has been included at the end of these minutes. Cpl. Carrado also said they had received a concern of a person sleeping in the park pavilion. Frequent checks made by officers of the area. No one has been seen.

Sgt. Bruce DeGrange was on hand to talk about holiday safety. Tips included:

- Make sure your car doors are locked
- Bring a blanket to put over packages in the car
- Be aware of your surroundings
- Bring only minimal stuff with you when shopping (leave as many credit cards at home)

GUEST SPEAKERS:

- Blighted & Vacant Properties – Alderman O'Connor
The Blighted and Vacant Property Ad-Hoc Committee was appointed by Mayor McClement to evaluate the current status of and policies regarding vacant and blighted commercial and residential properties in the city, and recommend policy initiatives (regulations and incentives) to encourage/require reasonable maintenance, reinvestment and occupancy of such properties. That effort was broken into two phases: 1) Commercial Properties and 2) Residential Properties. This report is on Phase I - blighted and vacant commercial properties. The second phase report will be on residential properties and will be issued later this year.

Alderman Russell was on hand to talk about the Bicycle Ad Hoc Committee. Alderman Russell talked about the 2nd Phase of the Bike Lane Project. The City of Frederick has begun work on the 2nd phase of the 7th Street Bike Lane Project. Motorist and pedestrians will see installation of new pavement markings and signage along 7th from Taney Avenue to East Street. The work will take place between 9:00AM and 2:00PM beginning Wednesday, November 14th. Temporary lane closures will take place during the work, please beware of the Public Works staff in the installation zones.

In May 2012, The City of Frederick received a Bronze Level designation as a 2012 Bicycle Friendly Community by the League of American Bicyclists. This award recognizes the dedicated work of the City's Ad Hoc Bicycle Committee. Tim Davis, Planner for The City of Frederick, received notification of the Bronze status from the League of American Bicyclists on April 27, 2012. Funds for this project are courtesy of the Maryland Department of Transportation.

The Department of Public Works is anticipating the duration of this project to be approximately 6-8 weeks.
