RESOLUTION NO: 10-02

A RESOLUTION CONCERNING

VIOLATIONS OF TAXICAB ORDINANCE

WHEREAS, The City of Frederick regulates taxicabs for the protection of the public health, safety, and general welfare; and

WHEREAS, on October 18, 2007, the Mayor and Board of Aldermen enacted Ordinance No. G-07-20 for the purpose of repealing and reenacting Chapter 23 of the Frederick City Code, entitled "Taxicabs" (hereinafter the "Taxicab Ordinance"); and

WHEREAS, the Taxicab Ordinance provided that any violation thereof is a municipal infraction, punishable by a fine not to exceed \$1,000, in accordance with a schedule adopted by resolution of the Board of Aldermen; and

WHEREAS, on December 6, 2007, the Mayor and Board of Aldermen adopted Resolution No. 07-30 for the purpose of adopting a fine schedule for violations of the Taxicab Ordinance; and

WHEREAS, on October 1, 2009, the Mayor and Board of Aldermen repealed and reenacted with amendments the Taxicab Ordinance by enacting Ordinance No. G-09-12 (the "Amended Taxicab Ordinance"); and

WHEREAS, the fine schedule for violations of the Taxicab Ordinance established in Resolution No. 07-30 must be revised so that it corresponds accurately to the Amended Taxicab Ordinance; and

WHEREAS, on October 13, 2009, the Taxicab Commission voted to recommend approval of the revised fine schedule to the Mayor and Board of Aldermen; and

WHEREAS, the Mayor and Board of Aldermen wish to accept the recommendation of the Taxicab Commission.

NOW THEREFORE, BE IT RESOLVED that the Mayor and Board of Aldermen of The City of Frederick hereby adopt the attached Schedule of Fines, dated January 7, 2010, setting forth specific penalties for violations of the Amended Taxicab Ordinance.


BE IT FURTHER RESOLVED that this Resolution supersedes Resolution No. 07-30.
