GUEST SPEAKER:

Kevin Contardi, President Police Activities League

The Frederick Police Activities League (PAL) is a recreation-oriented juvenile crime prevention program that relies heavily upon athletics and recreational activities to create and cement the bond between police officers and the youth in the community.

PAL is a non-profit 501 (c) (3) organization that serves youth between the ages of eight and eighteen. PAL offers its programs free of charge and intends to offer free entry to the skate park as well. Since 2003, there have been more than 44,500 visits to the PAL programs.

Historically, there has been no place to skateboard in downtown Frederick. For years, random youth skateboarding has resulted in business and resident complaints and damage to historic property.

With the completion of the latest phases of Carroll Creek Park, these issues have exacerbated, resulting in increased skateboarding and trick riding. This, in turn, has caused a heightened and unwanted sense of disorder downtown and on Carroll Creek. Property damage has escalated. Police enforcement is difficult and the most expensive and least effective long term solution.

The CDBG Ad Hoc Committee has recommended awarding funding of \$87,450 from CDGB and would like to retrofit the one of the basketball courts in Sagner Park into a free of charge youth skateboarding park. This project also will reconfigure the second basketball court into two half courts, and update fencing and lighting in the park. The proposed skate park will feature streetscape type ramps such as curb stops and rails, all low to the ground.
