





How would you describe the parking areas along the Golden Mile? (check all that apply)



Do you think that mixed-use buildings (i.e. buildings with both commercial/office and residential uses) would be appropriate along the Golden Mile corridor?







If you were starting a new business today, how likely would you be to choose the Golden Mile as a location?




Does your business currently recycle aluminum cans, glass, paper, or other materials?

1	Local immigration office, there is more crime happening then gets reported.
2	I would love to see this area revitalized. It's such a pretty part of Frederick, but it seems to have been neglected over the years - especially the Frederick Towne Mall.
3	Add more stores
4	Reduce Crime and better police patrols along Hillcrest Drive
5	Why aren't we attracting name brand stores and specialty stores, is it because rent is too high? We really need to resolve the issue with the Frederick Towne Mall - Women are 90% of the consumer and many of our customers have expressed fear in going to the mall because of the lack of shoppers and the potential for crime. The mall used to be an icon.
6	Proper street lights, lights in business surroundings, control crime rate (which is a must), should encourage more businesses, avoid business closures, lower the taxes, should bring more tourists and visitors, hold more exhibitions to reach out to customers.
7	Speed up the recovery of the Frederick Towne Mall. It's been empty far too many years and is starting to become an area where the wrong crowds hang out and the people who used to go there will not go anymore because of safety reasons. Get the mall going and it will make a big difference for Rt. 40 - the Golden Mile.
8	The major problem as I see it is the economy. With the correct economic conditions it is very hard to open or expand a business. Rents are still high, other expenses taxes and utilities are still high and it is hard to borrow money. Somehow we need to make it easier to fill some of the empty spaces. Most of my customers prefer to shop the Golden Mile rather than the Rt. 85 corridor but they do not have the right tenant mix on the Golden Mile. Our current landlord has made a big investment in what was a derelict center and can't get tenants due to current economic conditions.
9	GetGo / Giant Eagle may be engaging in the anti-trust violation - Selling below cost of gasoline. Fuel perks discount of 20 cents per gallon for every \$50.00 spent in grocery store far more generous than any other grocery/gas promotion. This practice has already been found illegal in several other states.

11Need more business in the Vista Shopping Center

I have been on teh mile for 20 years. My biggest complaint would be how the major centers "view from the road" is blocked by "pad sites" stuck in front of them. Obviously done to better use 14the space but it creates a cluttered look that does not "flow". The mile appears to be a "hodgepodge" of business and cents "thrown" together with no "master plan", no symmetry.

Crime - It is what we hear about the most. Our office is open till 5 PM M-F. If any of our office staff needs to be here after hours they try to avoid this at all cost. We hear this from other 15businesses up and down the road. Thanks for this survey.

16The Fredericktown Mall needs more shops. Also a long John Silver Restaurant would be great back on the Golden Mile. More kid oriented businesses

Glad this is happening. Far too much focus on downtown. Downtown businesses get a lot of leewaydue to the grandfather laws. 
