POLICE REPORT:

Sgt. Greg Stocksdale addressed public safety concerns and shared NAC3-area statistics, which are listed at the end of these Minutes. He said that thefts from motor vehicles still continues to be a problem and reminded residents to please lock their cars. He also reminded residents that if they have parking issues they can call the non-emergency phone number at 301-600-2102.

Chief Ledwell was also on hand and talked to residents about data driven policing.

PLANNING:

- Water Tower – Zack Kershner
The new tower will help with water pressure problems. Especially when there is high demand during the summer. The water tank will help stabilize your pressure but. It won't increase the pressure. There is not a specific design yet. The RFP was just sent out last week. This will go to the Mayor and Board for approval. Pre bid meeting is March 6 with proposers and they will answer any question. Bids are due April 4th.

GUEST SPEAKERS:

- **Lisa Orr - Green Challenge**
Lisa was on hand to talk to residents about the Frederick Green Homes Challenge. She talked about special initiatives such as solarize Frederick county. The new initiative is the Refrigerator Exchange Program. This program provides eligible households with a free energy efficient, Energy Star rated refrigerators in exchange for a qualified less efficient model. All the exchanged refrigerators will be collected and recycled in an environmentally-sound manner. First grant hopefully about 100 to give away and for second grant which has not yet been awarded hopefully another 200 for a total of approximately 300.
