### ***POLICE REPORT:***

Sgt. Pue was in attendance to talk about the police statistics as well as address any issues and concerns. Sgt. Pue said that crime as a whole is down and addressed a few issues. The department is still seeing thefts from motor vehicles so he reminded residents to please lock their car doors. There have also been some daytime burglaries in the downtown area and request that residents lock their doors and their windows. The suspects are making entry through open windows.

**Description:** The subject property contains two lots that connect through from West Patrick Street to West South Street. In addition, the property has three zones applied, DB (downtown business), DR (downtown residential), and is within the HDO (historic district overlay). The development proposal is solely residential with a community building space. The project is considered redevelopment. DB and DR zones have a density permitted as high as 75 and 40 units per acre, respectively. Although density is high, the project could never satisfy parking for the maximum of 95 units and proposes only 71 units. The plan is presented cannot provide required parking for the units on site and is proposing off-site parking arrangements in perpetuity.

### ***GUEST SPEAKERS:***

#### **Richard Griffin – Economic Development – Hotel Project**

Richard talked about this being the early planning stages of the project. He mentioned that it would have to meet the guidelines from the Historic Preservation Commission. He took questions and two attendees both mentioned what appear to be inadequate parking facilities on site and expressed concern about traffic and downtown parking congestion. One resident asked how it would be funded and it does turn out that some of the money would come from residents' tax dollars. Richard said there is a study about to take place related to parking and traffic. He also said that when they have another meeting it would be listed on the public agendas. And residents could come to those meetings.

#### **Nikki Bamonte – City of Frederick - Code Enforcement Update**

Nikki was on hand to talk about Code Enforcement and give updates on properties within the NAC 11 area. She also discussed the blighted property list. She said there were 4 properties that were initially put on the list. There is also a watch list for properties that could be put on the blighted property list. Once a property makes it to a list it is on there for 12 months after the violation has been corrected. Each of the property owners of the blighted and watch list properties received a letter.

A resident asked why properties were not being condemned anymore and why 314 North Market Street was not on the list?

Another resident asked about the restriction of sidewalk access in the downtown area. There are some areas where the tree wells encroach in the walking space and it is hard to get around. There is one area by Magoos Restaurant. Nikki said that she will invite someone from the city to address this.

Nikki also discussed the property at West 4<sup>th</sup> Street. She said the city just took ownership of the property and that it is not a clear title to the property. The last court proceeding granted the city right of possession.

A resident asked why the graffiti on the former bagel shop has not been removed. Nikki said that since the brick has never been painted it has to go before the HPC to be approved first.

Nikki also reminded residents that they can access Code Enforcement information online at anytime.

**Kara Norman - Downtown Frederick Partnership - 7th street fountain project**

Kara wanted to update everyone on the 7<sup>th</sup> Street Fountain. Currently there is no funding for the project or to make any of the improvements. She also said there are no set final plans for the project and still open to suggestions. Kara showed some possible suggestions.
