

SPECIAL ORDINANCE S-16-19

A SPECIAL ORDINANCE TO AMEND THE BUDGET OF THE CITY OF
FREDERICK FOR THE FISCAL YEAR JULY 1, 2016 TO JUNE 30, 2017, TO
INCLUDE REVENUE AND ASSOCIATED EXPENDITURES FOR THE
MONOCACY BOULEVARD CENTER SECTION PROJECT

WHEREAS, by Article VII, §5 of the Charter of The City of Frederick it is provided that the budget shall be prepared and adopted in the form of an ordinance upon a favorable vote of at least a majority of the total membership of the Board of Aldermen; and

WHEREAS, the Mayor and Board of Aldermen did meet in public on May 19, 2016 and did by a majority vote to accept and approve the budget, as submitted by the Mayor in a public meeting of the Mayor and Board of Aldermen on March 30, 2016, and as amended by memoranda from the Mayor to the Board of Aldermen dated May 3, 2016 and May 13, 2016, and as amended at the meeting of the Mayor and Board of Aldermen on May 19, 2016 and passed by a majority at the meeting of the Mayor and Board of Aldermen on May 19, 2016 as required by Article VII, §5 of the Charter of The City of Frederick; and

WHEREAS, the Mayor and Board of Aldermen did adopt and enact the budget on May 19, 2016, as required by Article VII, §5 of the Charter of The City of Frederick; and

WHEREAS, the Mayor and Board of Aldermen did adopt and enact the budget on May 19, 2016, to take effect on July 1, 2016, by Special Ordinance S-16-06; and

WHEREAS, subsequent to the adoption and enactment of the budget the City learned the cost for the next phase of the Monocacy Boulevard project would be higher than anticipated; and

WHEREAS, subsequent to the adoption and enactment of the budget Frederick County requested the City include \$526,500 of sewer work in the project that will be fully reimbursed by Frederick County; and

WHEREAS, the Capital Improvements Program budget as adopted and enacted by Special Ordinance S-16-06 must be amended to include additional debt issue revenue of \$5,300,000, County grant revenue of \$4,026,500, and construction expenditures of \$9,326,500.

NOW, THEREFORE:

SECTION I: BE IT ENACTED AND ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF FREDERICK, that the budget for The City of Frederick for the fiscal year July 1, 2016 to June 30, 2017, as submitted by the Mayor in a public meeting of the Mayor and Board of Aldermen on March 30, 2016, and as amended by memoranda from the Mayor to the Board of Aldermen dated May 3, 2016 and May 13, 2016, and as amended at the meeting of the Mayor and Board of Aldermen on May 19, 2016 and passed by a majority at the meeting of the Mayor and Board of Aldermen on May 19, 2016, as required by Article VII, §5 of the Charter of The City of Frederick and as adopted and enacted on May 19, 2016, by Special Ordinance S-16-06, and effective July 1, 2016, be and the same is hereby amended to include additional debt issue revenue of \$5,300,000, County grant revenue of \$4,026,500, and construction expenditures of \$9,326,500.

SECTION II: BE IT FURTHER ENACTED AND ORDAINED BY THE AUTHORITY AFORESAID, that this Ordinance shall take effect on December 15, 2016.
