### ***POLICE REPORT:***

Sgt. Joe Simmons was in attendance to talk with residents about any issues or concerns that they were having. Sgt. Simmons said that they were doing stop sign enforcement, but it is still an ongoing issue.

A concern was brought up about a large bus stop in the Workman’s Mill area.. Residents asked if FPD could provide a bus stop person for the large bus stops as kids are crossing the street without looking. Sgt. Simmons said that FPD could not, and we only use Crossing Guards in proximity to schools, not in individual neighborhoods. A discussion was had that maybe FPD could do a training with parents and children teaching them how to properly cross the street.

Another concern was people parking the wrong way in Worman’s Mill and trucks starting work behind Covington Station around 0530 (Aero Gas).
