CODE OF CONDUCT



Dear Parent / Guardians:

The PAL program brings youngsters and police officers together in a recreational setting. The police officer's role is the reinforcement of the values and attitudes instilled in young people by their parents. The PAL program promotes a greater trust and understanding between youngsters and Officers.

The well being of your child/children is of the utmost concern to us while they are participating in the Frederick Police Activities League (PAL) programs.

In putting the safety of your children first we have developed a code of conduct that will be in effect while the center is open. Please review this code of conduct with your children.

CODE OF CONDUCT

1. All youth must have a current signed registration form before participating in any PAL programs.
2. All youth must sign in and out when entering or exiting the PAL Center.
3. All youth must use only designated entrances and exits.
4. All youth must show respect for staff, other youth and equipment.
5. Obscene language, racial slurs, or sexual remarks will not be tolerated.
6. No lying, cheating, stealing or fighting.
7. Possession of/use, or being under the influence of alcohol and/or drugs is prohibited.
8. Sexual contact/activity in the PAL Center will NOT be tolerated.
9. No loitering outside of the PAL Center.
10. Dress policy will adhere to Frederick County Public Schools.
11. Youth are responsible for their personal property brought into the center.
12. No cell phones are allowed in the center (unless specific permission).
13. No food or drinks other than those given by PAL staff are allowed in the PAL Center.
14. Youth are expected to participate in activities without disrupting the program; if they are disruptive they will be asked to leave the center.
15. Anyone who enters the PAL Center is subject to search.
16. Any youth asked to leave the center will receive a behavior form indicating why the child was asked to leave. In order for your child to return to the PAL Center this form must be signed by the parent/guardian and returned to PAL Center staff.

Membership at the PAL Center is a privilege. Anyone who enters the Youth Center must follow our rules of conduct and dress code. Violent or aggressive behavior is not tolerated at the Youth Center. Anyone entering the Youth Center is subject to a search of their person including any bags or packs. Do not bring weapons or other inappropriate items into the center.

All youth are expected to be respectful of others including Youth Center neighbors. Membership may be revoked at any time if PAL determines that it is in the best interest of our organization. The safety of youth and staff at the center is our primary concern.

I also understand that the PAL Center may be closed without warning due to weather, police emergencies, or other duties.
