In response to your letter received on June 9, 2022, Staff has prepared the following information:

After discussion with you on the phone, it was determined that the request is for installing the solar panels on a rooftop at the above address. This is not a determination of starting a business location in Frederick and therefore, not required for determining the zoning for any specific location. In order to perform the work as described, please contact the Building/Permit Department at 301-600-3808 for instructions to submit a building permit for the work.

Please be advised that any person aggrieved, or any officer, department or agency of The City of Frederick affected by an order, requirement, decision, or determination made by an administrative officer in the administration or enforcement of the provisions of the Land Management Code may appeal said decision within thirty days to the Zoning Board of Appeals.*
